

Outcome analysis as of 30 June 2022










Select Accumulation and Select ESG: outcome chart



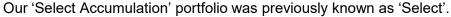





Outcome analysis as of 30 June 2022






