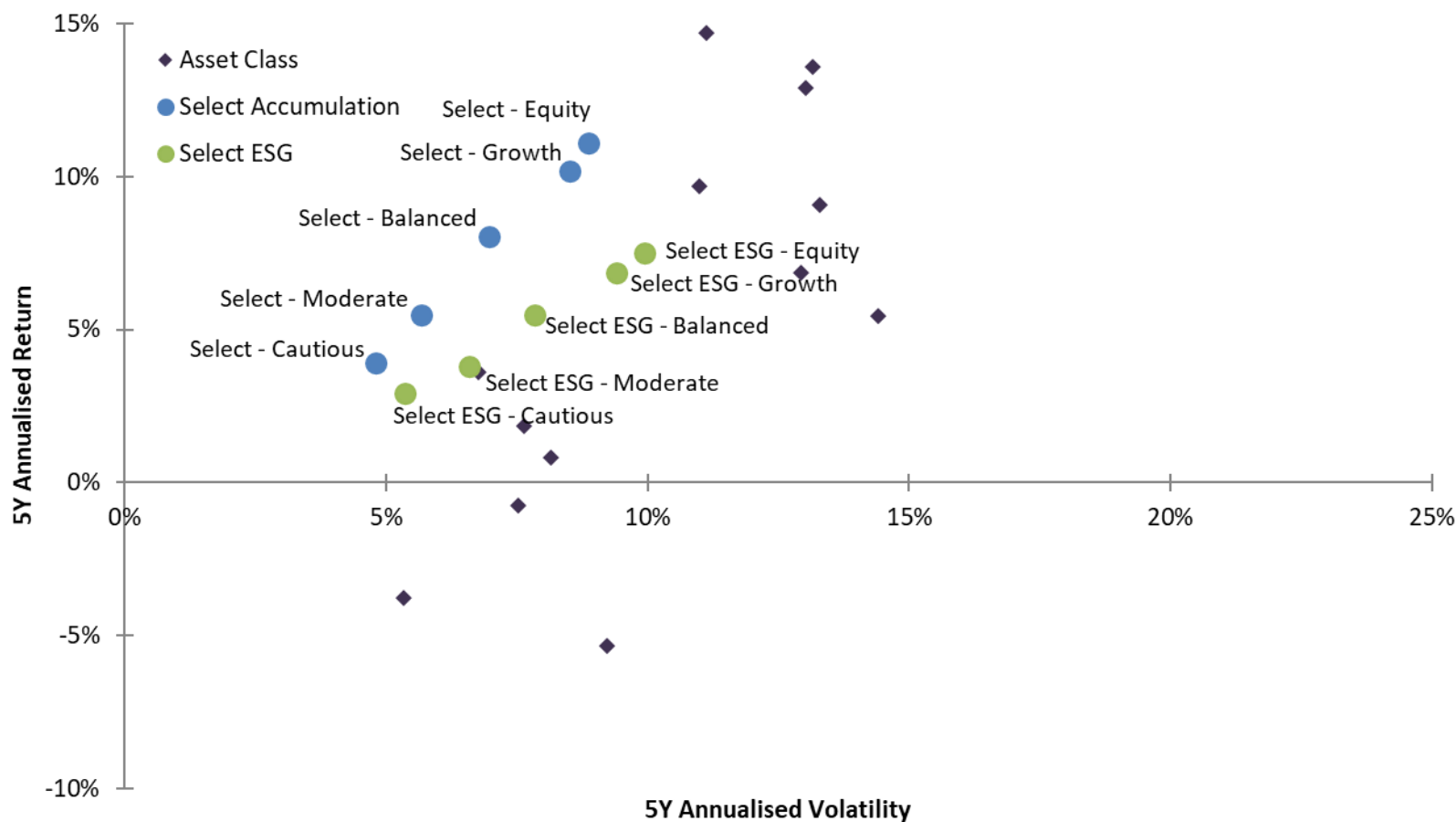

Outcome (risk-return) analysis as of 31 October 2025



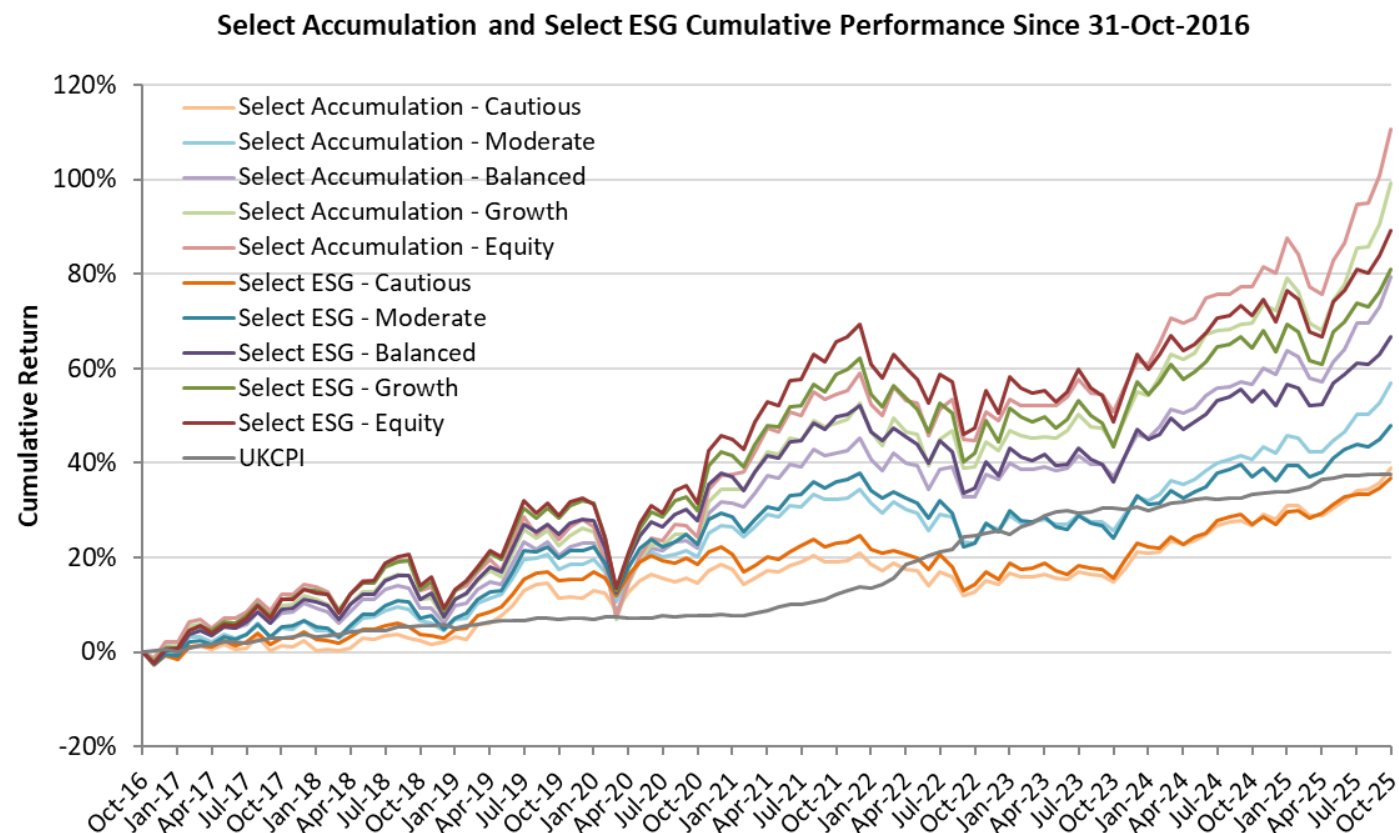

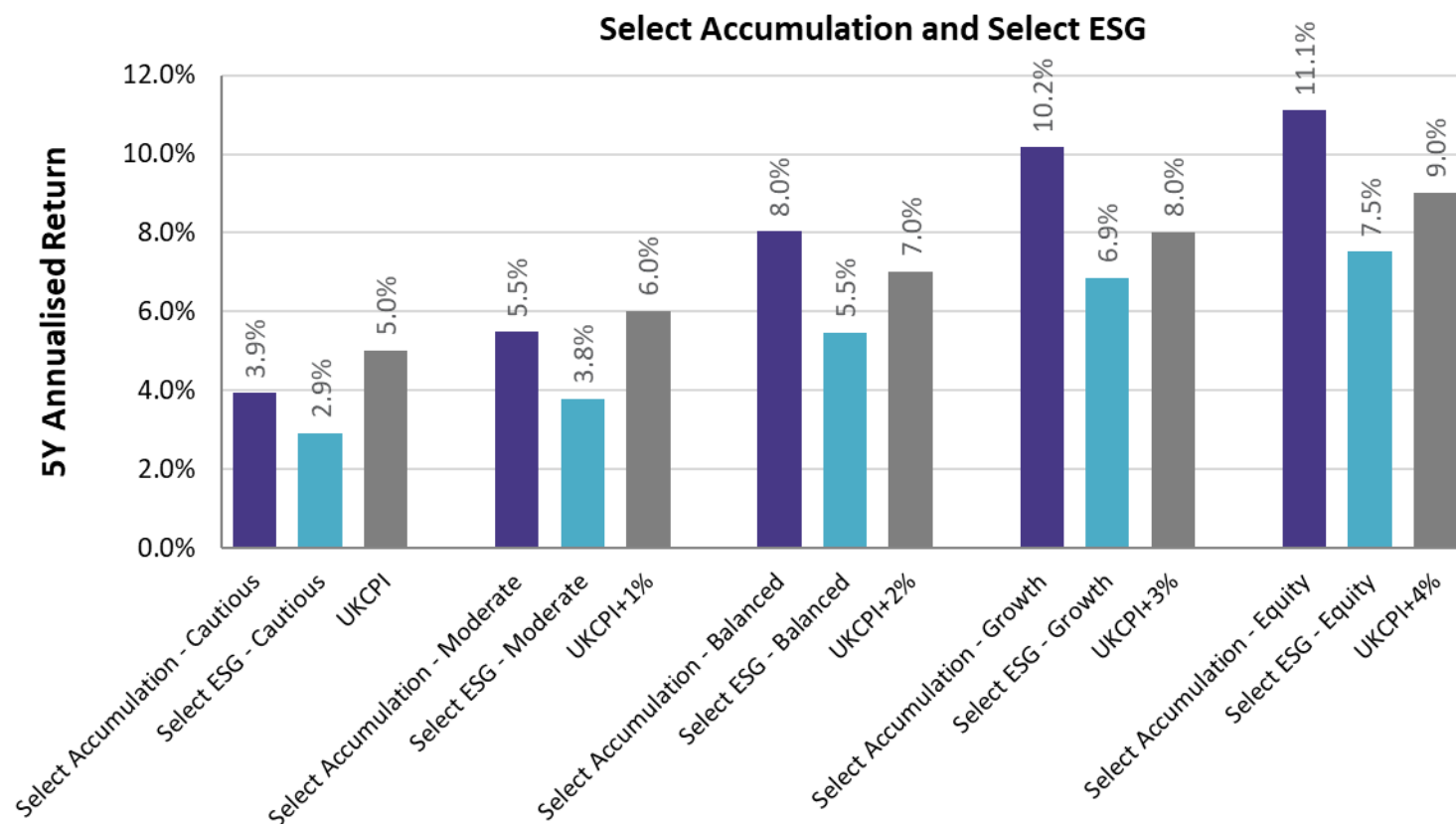

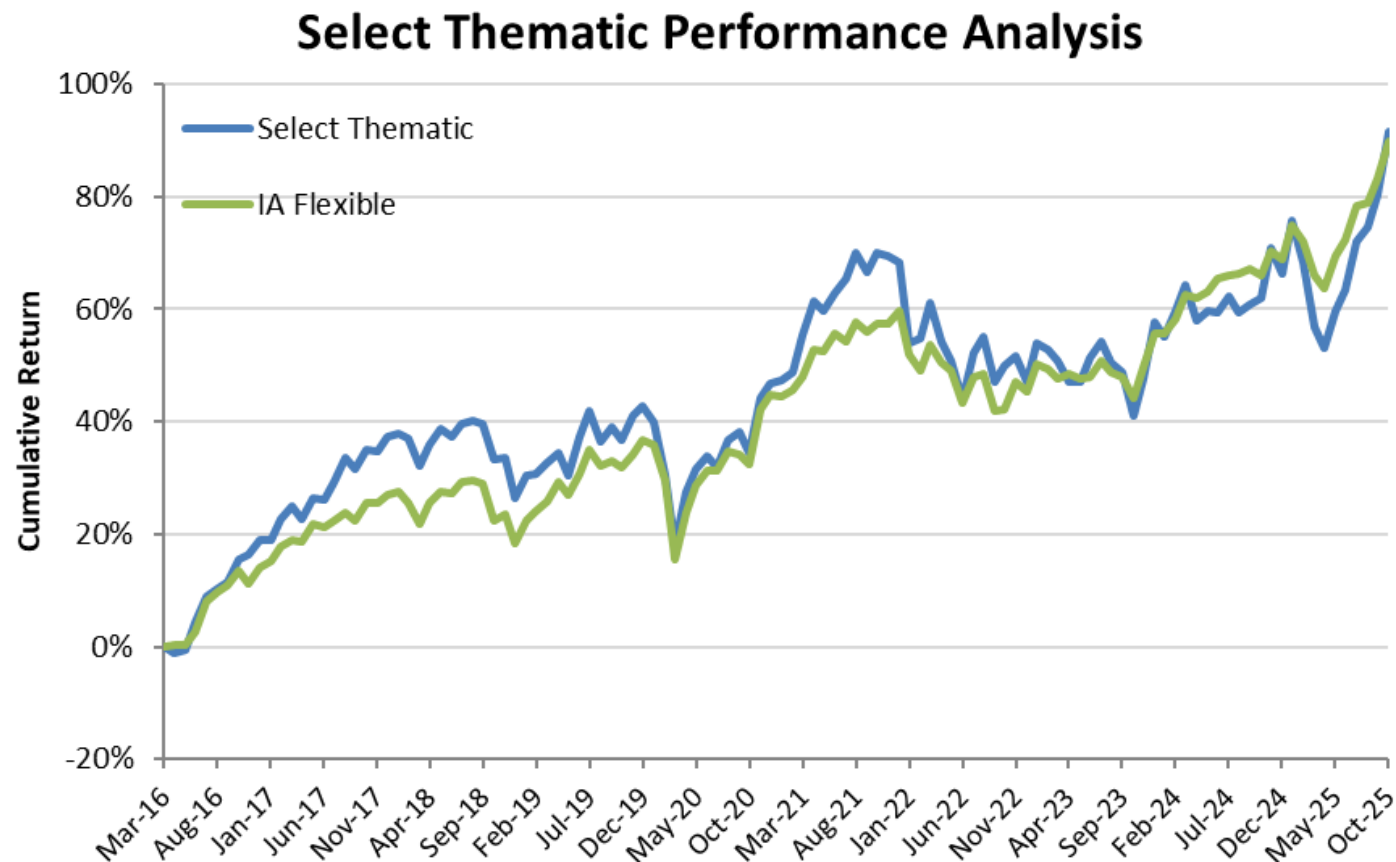
