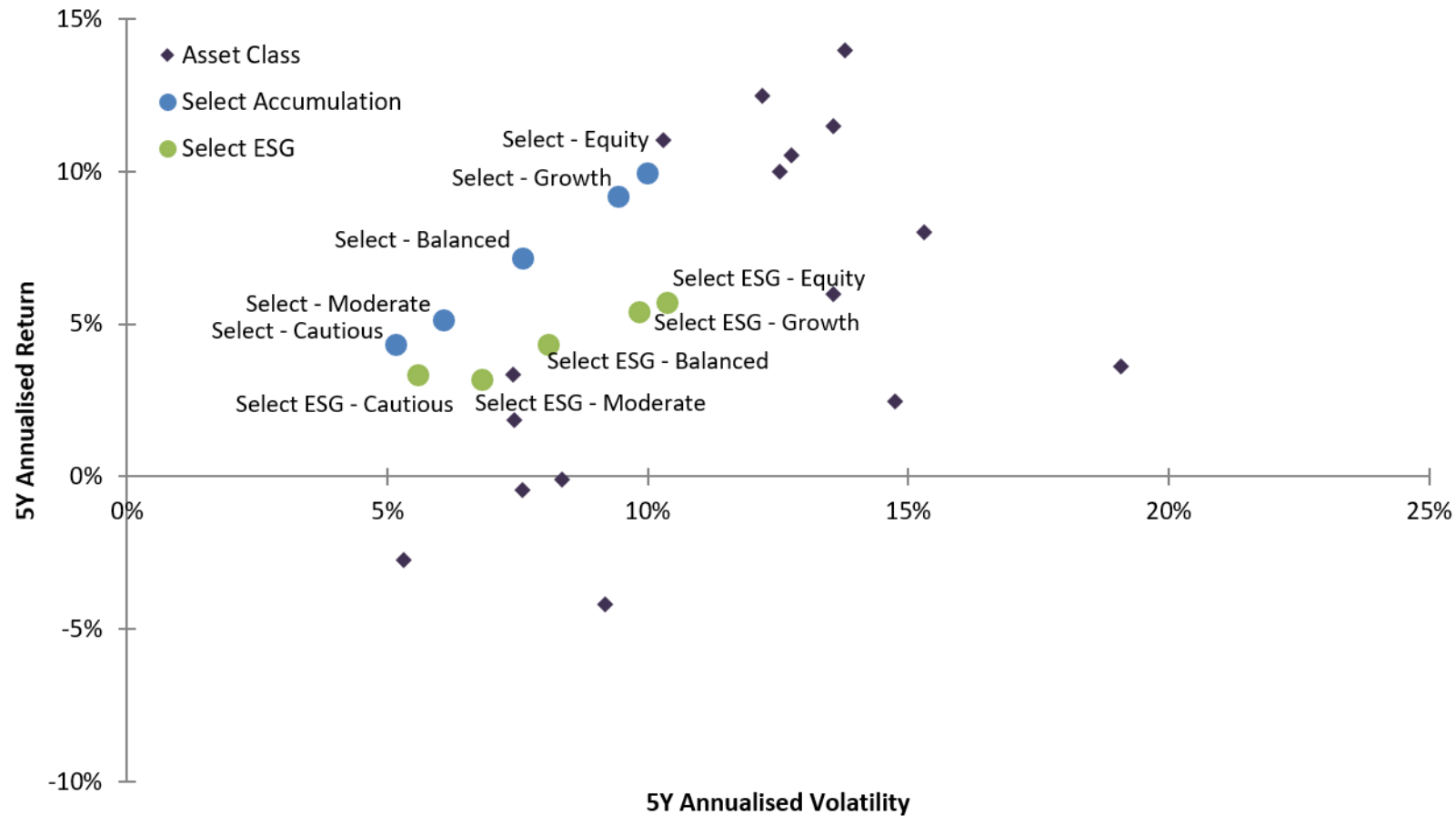

Outcome (risk-return) analysis as of 30 June 2026



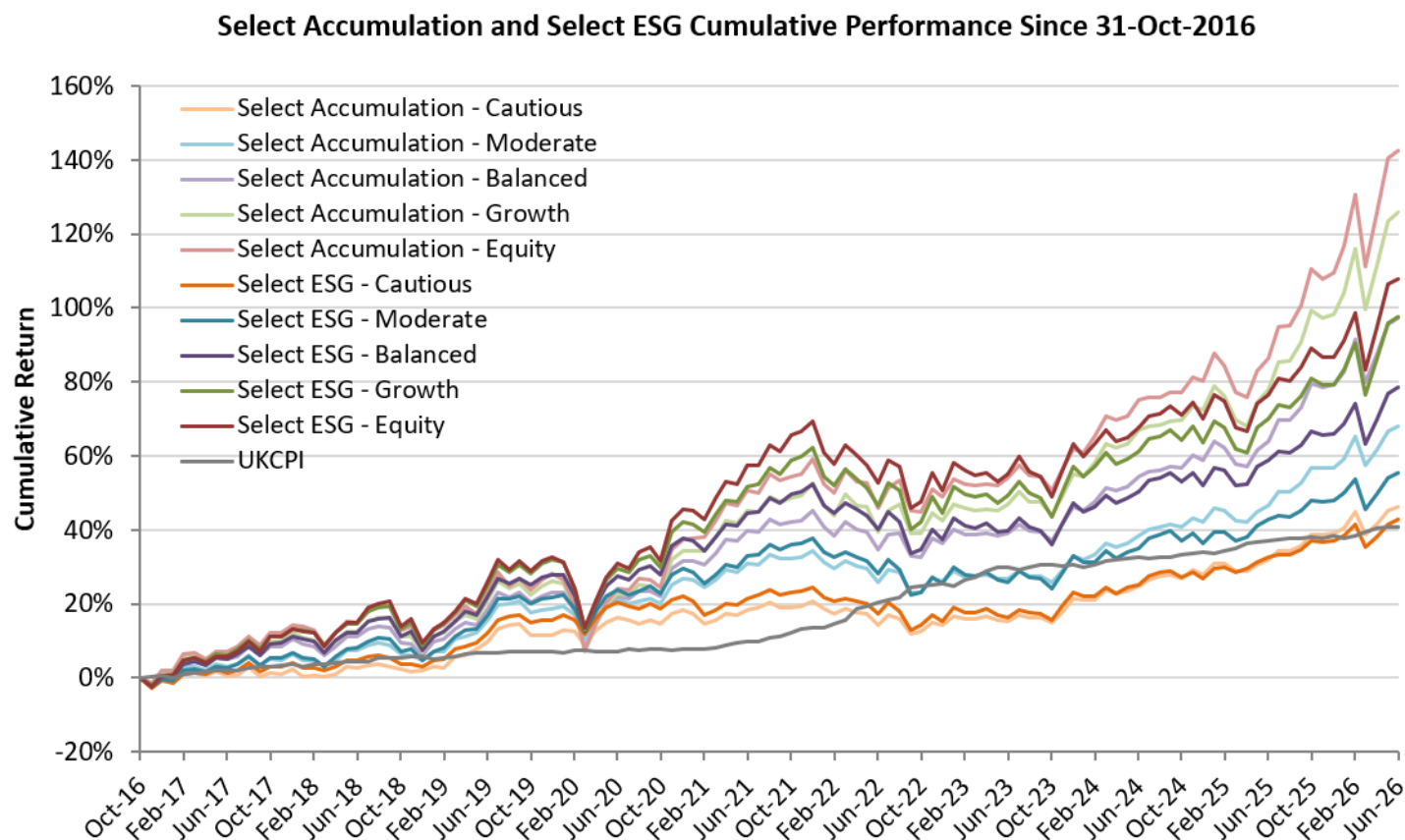

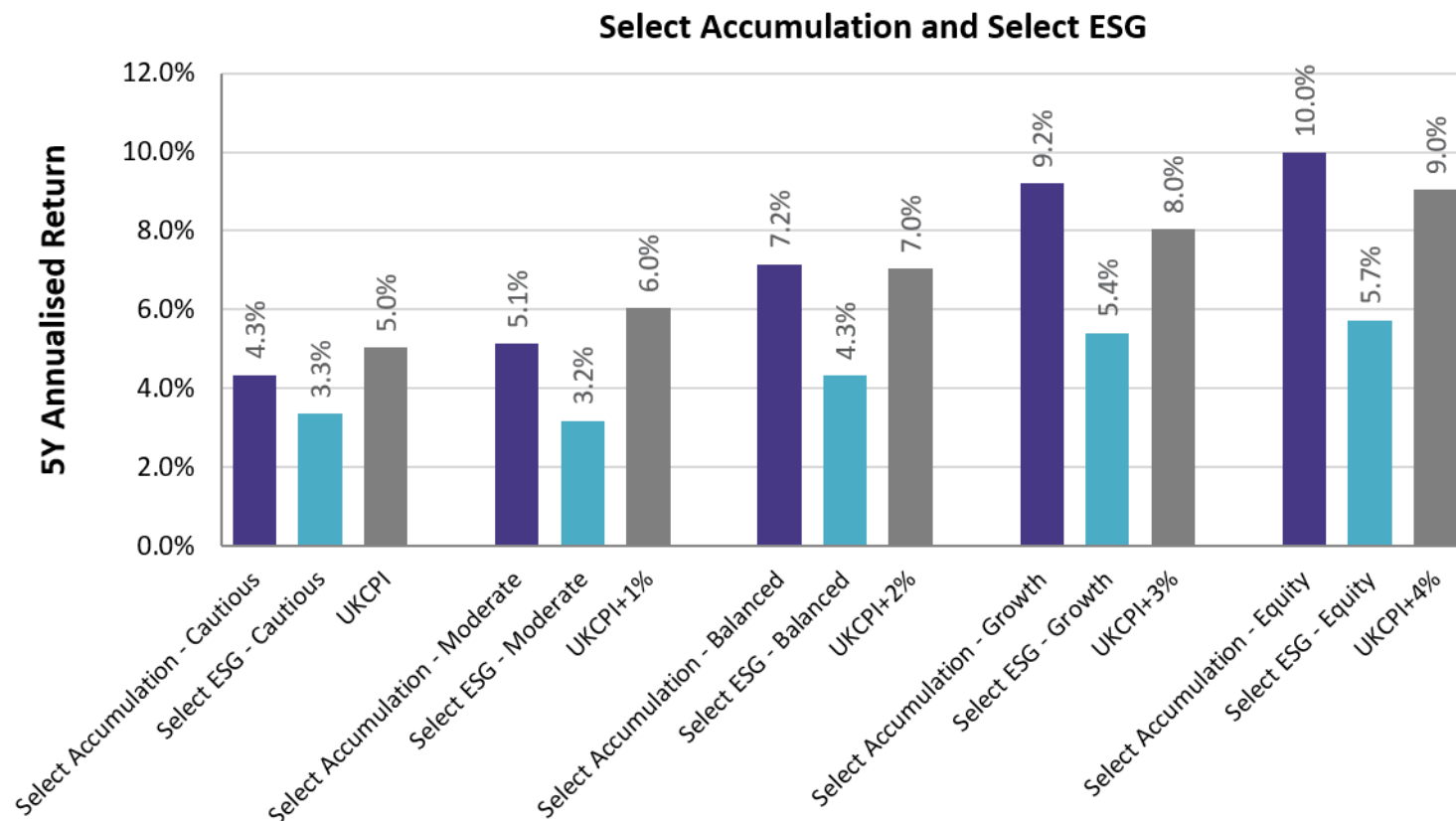
